Baptist Church of Douglass Park and America Homelessness Coalition want to do more for the needy and homelessness in Chicago to help them get back on their feet to become financially independent. Homelessness Financial Relief Program have become highly favorable in Illinois, Cook County and Chicago. Baptist Church of Douglass Park and Putting America Back to Work Movement implemented the Community **Employment Program to help** provide those good paying jobs to minorities in this great nation. Community Employment Program has provided the good paying jobs in South Carolina and Illinois. Enrollment dates for employment opportunities in the program will I be November 28, 2015. It will be enrollment for the Education Tuition Assistance Program to provide financial assistance to students to help them pay for

college and graduate school. Social service enrollment dates in Illinois was November 20 in Douglass Park and November 21 in Chatham. Church receipts are still being counted and calculated for the Community Employment Program because it provided so many good paying jobs in this nation and put people back to work with permanent job security. Also, Senior Pastor Nicolas Hobson has given to homeless people on the streets of Chicago personally to help them buy food. He has given homeless people in Chicago his lunch or food on CTA trains. He has helped minorities in Chicago with train and bus fare during the summer and winter months personally. After the Senior Pastor moved to lowa, homelessness among adults and children have increased by 140,000. It is time to keep social services in Illinois to help the needy and homelessness. A new office will be moving to Philadelphia in the near future to assist needy and homelessness with education financial assistance.

homelessness financial relief program to the homelessness in Philadelphia. Senior Pastor support rebuilding the middle class and reducing poverty. Senior Pastor Nicolas Hobson savs he will do more for the homelessness personally in United States of America. He likes to work with Rahm Emanuel on this critical issue because he support his Homelessness Prevention 2.0 plan since January 2014. The church and coalition have total receipts in amount of \$14,760.47 for 2015 IRS 990 from homelessness outreach and church operations. The church provided Senior Pastor, Budget Committee members and Pastoral Care Ministry provided \$910 of cash and noncash donations to homelessness and needy in Chicago and Dubuque. Putting America Back to Work Movement has \$1,720 in receipts under the leadership of Nicolas Hobson as President. He provided an exit strategy for the organization in February 2014.

Church Board of Directors like to bring jobs from the Community Employment Program to Dubuque and Iowa.

Homelessness Prevention Bill is still sitting in committees on Capitol Hill to provide more subsidized

and affordable housing in states in the United States of America. The bill give state \$1 billion to provide more low-income affordable housing and subsidize housing to end long waitlists. The church has been gaining more

support among men because more men are more engaged within the church than women. Church has support from men age 25-44 nationwide. Church has 53% of support from men in the United States of America

based on community survey statistics. The church board of Directors paid the \$850 user fee to the IRS on September 29, 2014 because we knew we will have more than \$10,000 budget. Monthly treasurer reports are updated weekly and monthly by Office of the Treasurer in Chicago. Nicolas Hobson is a proponent of the Sentencing and Corrections Act that is sponsored by Senator Cory Booker (D-NJ) because he supports criminal justice reform. Homelessness Financial Relief Program is expecting to make good impact to 76 homelessness in Chicago this year by providing them with financial assistance. Church website is almost done with its updates. Website will be fully ready soon. Pastor Nicolas Hobson is challenging the Democrats in 2016 as an independent on economy and fiscal issues because I support protecting Americans pocketbooks from higher taxes.

Lower taxes will increase wages at employers nationally to help people get out poverty. Employers will have the revenue to give their employees a pay raise if taxes remain low. Lower taxes will put more money in their pocketbooks on a daily basis. What is the Democrats plan to grow the economy without big government and raising taxes? How will they work with the Republican controlled Congress on economic issues without big government? Ronald Reagan said "Government is not the solution to the problem. Government is the problem." Black communities and some Americans nationally are complaining among themselves about the Democrats raising taxes and causing more Americans to have less money in their pocketbooks. Pastor Nicolas Hobson actually heard and talk to low-income families on the streets of Chicago about their fiscal issues. She is financially struggling paying her utility bills, so the church Homelessness Financial Relief Program has helped her with financial assistance. Chicago resident talked to the church treasurer office staff for financial assistance. Chicago resident is a single mother with young children that lives on the Southside of Chicago. Homelessness Financial Relief Program already provide financial assistance to 65 Chicago residents and likes to expand the social service program to city of Dubuque.
