God helped me find my passion to help the homeless and low-income communities starting in 2011 in Chicago with Pastor Hobson Homelessness Initiative. Pastor Hobson Homelessness Initiative started out as personal grassroots project on west and south side of Chicago while I was an undergraduate student. I have over 1000 volunteer hours helping the homeless in Chicago at homeless shelters, Catholic Charities, Grace Place and Rainbow Push Coalition, Salem Baptist Church of Chicago Homelessness Ministry and churches in 2011-2015. I have 200 volunteer hours helping the homeless in Detroit in 2017-2018 at Detroit Rescue Mission Ministries. I have 10 volunteer hours helping the homeless and low-income communities in Cleveland in 2017 at The City Mission. Pastor Hobson Homelessness Initiative personal and professional support in Chicago south and west side helping the homeless and low-income families. Illinois and Chicago politicians told me and respect my grassroots project helping the homeless and low-income communities. Pastor Hobson Homelessness Initiative expanded to Global Homelessness Initiative for Lord Jesus Christ Community Baptist Church.

My involvement and experience from Celebrate Recovery at Salem Baptist Church of Chicago.

1. Provide outreach and motivation for homeless people in 2011-2015
2. Help homeless people with leftover food and money for food
3. Mentor homeless people on career and workforce development
4. Became strong advocate for the homeless and low-income communities since 2011
5. Donated \$7,973 of my own money in Chicago to help the homeless based on personal tax returns and IRS transcripts
6. Donated \$1,560 of my own money to help the homeless and low-income communities in Iowa, Illinois, Ohio and Michigan
7. Advocate for affordable housing, less taxes in economy, reduce section 8 wait lists , end child poverty and fight for religious liberty

I think about others and homeless people before I think about myself. I visualize and and put myself in homeless people and low income families situations when living paycheck to paycheck, living on squeezed finances in households by higher taxes implemented by Democratic Party in this country, living on fixed income and low income, living in homeless shelters longer periods of time trying to seek permanent housing and affordable housing, single parent households. I am a cheerful giver to the poor. I offer new ideas and advice to homeless people, community leadership since 2011 at Homelessness Task-force meetings. I created an action plan for Pastor Hobson Homelessness Initiative in 2011. I coached homeless people in Chicago with obedience, bible, temptation, sin, worship and self-control.
