# BUDGET COMMITTEE AND PASTORAL CARE MINISTRY PROJECTIONS

Homelessness Financial Relief Program bas \$9,143 in receipts from financial assistance to the homelessness in Illinois. Homelessness Financial Relief Program has provided financial assistance to one hundred six (106) homeless people in Illinois. Pastoral Care Ministry staff in Illinois and Chicago has provided \$8,311 for noncash donations to the homelessness and needy in Illinois. Community Employment Program Job Reports are accurate in

Illinois and nearly 12,000 full-time jobs have been provided in Illinois. Full-time workers work at staging location in Illinois communities managed by church members and supporters. Community Employment Program will expand to Michigan and Northwest Indiana. Homeless people do not want to live in homeless shelters because some homeless people are LGBT. Some homeless people are uncomfortable being around men that may be LGBT. Pastor Hobson had talks with Budget Committee by conference call on May 25, 2016 to expand the Homelessness Financial Relief Program to help more needy and homeless people in Illinois, Indiana, Michigan, Tennessee, Ohio and Northeast Iowa. Pastor Hobson likes to close public housing in areas like Dubuque, such as Theresa House, Hope House and other supportive housing facilities in Northeast Iowa and some parts of the Midwest.
