## **ECONOMIC HARDSHIP IN BLACK COMMUNITIES**

Black/African-Americans that live in suburbs and inner cities are living paycheck to paycheck. Black/African-American households use most of their income to pay bills, keep their housing, food and household expenses. After black/African-Americans pay bills and household expenses in their households, they have less money to consume in the economy. Tax increases and implementing new taxes will not solve the problem for black communities. Black/African-Americans need to keep more of their own money to pay household expenses, utilities, rent and mortgage. When more jobs are provided in the economy with lower taxes, it will boost tax revenue for state, local and federal government. It will give governments the revenue they need to pay for higher education funding, education, entitlement programs, affordable housing, transportation, infrastructure, veterans affairs, affordable healthcare and social services to homelessness and needy Americans in this country. Government is not the solution to the problem. Government is the problem. It needs to be a 40% payroll tax implemented for millionaires and billionaires in this country to allow them to pay their fair share in taxes to pay for tax breaks for 99%, education programs, social services, entitlement programs, free medical care for veterans to go to the VA and private doctors in this country, put money aside to start more blackowned small businesses in black communities. Lower and less taxes will end poverty and homelessness in black communities. When Democrats in state and federal government raises taxes, it hits black/African-Americans households the hardest in this country by taking away money from Americans pocketbooks to pay rent, mortgage, utilities, food and important household expenses. More and higher taxes provide less money for black/African-Americans to have to consume in the economy. ## **ILLINOIS POLITICS**

Democrats in Illinois did not give Pastor Hobson and his congregation credit for his outreach to homelessness and households living in poverty. Pastor Hobson had to move his businesses and congregation out of state of Illinois. He still does business with some Illinois residents in state of Illinois. Pastor Hobson congregation and outreach got hatred from black churches and pastors in Chicago, such as Pastor Green-Christians on the Move Outreach Ministries, Pastor James Meeks-Salem Baptist Church of Chicago, Governor Bruce Rauner, Illinois back caucus, Pastor Corey Brooks-New Beginnings Church of Chicago and so on. Small Business Program graduated 1,093 new and existing small business owners that gave them easy access to capital based on receipts and church records. Small Business Program expecting to graduate 256 new and existing small business owners in September 2016 in Los Angeles, California. Small Business Program has provided 70,650 jobs in the private sector since fall 2015 based on records and marketing statistical information. Computer and Job Training Program is expecting to graduate 234 Americans to help them get good paying jobs in the private sector. Homelessness Financial Relief Program has provided over \$19,000 for homelessness outreach and homelessness financial assistance based on receipts and applications. America Homelessness Coalition still provides current job opportunities to Chicago residents and relocate out-of-state to perform jobs within the coalition. Community Employment Program has provided 15,599 full-time jobs in the private sector in minority communities. Chicago State University still having financial problems after receiving state funding. If State of Illinois never ran my congregation out of state, Chicago State University could have been getting additional funding and took advantage of my church Education Tuition Assistance Program for students. Full-time workers in the program earn \$960/weekly gross pay and included in the overall budgets each month for America Homelessness Coalition. Chicago State University students could have been getting \$3,000/per semester to pay for college. Homelessness Financial Relief Program has provided financial assistance to 174 Americans since fall 2015 to help homeless people get back on their feet.
