- Lord Jesus Christ Community Baptist Church is a church that cares and has strong compassion for the homeless and needy. We help transform lives and restore hope for the homelessness and low-income individuals. 8 programs,
- Church membership stands at 10,313 based on updated membership records and database. This church started out small with less members and now a large congregation with 10,312 members. The church average attendance during services are 6,843+ members and visitors from in the State of Michigan and out-of-state from Indiana, Ohio and Western Pennsylvania.
- The church raised \$215.75 this month from tithes and offerings in Detroit for operations and programs based on church business bank statements, financial statements and receipts. Tithes and offerings are tax exempt based on the IRS tax revenue code for the church as a nonprofit organization. The church will file 990 N to the IRS in January 2025 like it did for previous tax years. The church is working to increase revenue for church operations in the near future to be able to do more and help the homelessness in Detroit. The church still files the 990 N form to be compliant with the IRS every year as a nonprofit organization, although an IRS representative told church staff by conference call in 2015 that churches are not allowed to file Form 990 every year.
