## ECONOMIC AND COMMUNITY OUTREACH

America Homelessness Coalition has a separate federal EIN number because it is a separate business entity. Business financials and bank accounts are kept separate from the church in Michigan. An office will be moved in Baltimore and Milwaukee with jobs and social services in January 2017. America Homelessness Coalition has \$5,900.37 in receipts and \$12,634.01 in assets. Baptist Church of Douglass Park had \$4,500 in receipts in 2014 when the church filed its IRS Form 990 in January 2015. Baptist Church of Douglass Park filed all its IRS and Illinois Form 990 since 2014. America Homelessness Coalition has \$9,327 in receipts from homelessness outreach since 2014. ## GUN CONTROL AND ENDING GUN VIOLENCE IN USA

The “Constitutional Gun Control and Economic Opportunity Act” sent to Capitol Hill this month. The legislation was sent to US Senate Foreign Relations Committee, US Senate Armed Services Committee and US Senate Judiciary Committee this month to address gun control and tough gun safety laws by protecting Americans rights under the second amendment, economic opportunities for ex-offenders and homelessness, economic opportunities for people with disabilities, Medicare and Medicaid, mental health and policing. Legislation addresses ending gun violence long-term, closing gun show loopholes by implementing national background checks, provide gun laws for gun manufacturers like it did in the Brady Bill, ending radical Islamic terrorism in this country. Legislation helps provide economic opportunity and resources for sex-offenders, people with arrest records and criminal backgrounds, and protecting Americans rights under the second amendment. Legislation will make sure police officers that provides killings and unconstitutional violence to unarmed citizens. Legislation make sure police officers that provides unconstitutional police shootings are held accountable by the US courts in the United States of America. Legislation addresses providing economic opportunity that will end economic hardships and poverty. Final legislation of the “Constitutional Gun Control and Economic Opportunity

Act” will be posted online. Legislation explains that the income gap for people with disabilities should be increased from \$1,500/year to \$10,000/year to allow people with disabilities to obtain good paying jobs while they keep their disability benefits under Medicare and Medicaid. The provision will not raise the national debt and government spending.
