I am better off today in Iowa than living in Chicago because I was struggling financially in Chicago. My personal finances feel like it was shrinking. I was somewhat feel like I was living based on depression in Chicago because I did not have enough money to live on in Chicago. I had to leave Illinois because taxes were too high and hard to start a business in Illinois. Economy in Illinois grows less than one percent because Illinois do not have high job growth. I do not support higher taxes as a moderate Democrat. I left the state of Illinois to Iowa where the taxes and regulations are low. I could not live in a situation no more living paycheck to paycheck. I could not live in Illinois no more living in poverty. I decided to pursue my political ambitions out-of-state of Illinois. I do not believe in higher taxes and big government because it causes poverty for businesses and households in Illinois. I voted for Barack Obama for President in 2008 and 2012 because I thought he was going to provide real change for the country. Barack Obama do not do enough because it still families that are homeless, living on food stamps and fixed income, and living paycheck to paycheck. American people do not want to live paycheck to paycheck in this country by working 2-3 jobs just to get by on low wage jobs. Democrats in Illinois do not understand that today. Democrats in Illinois General Assembly continue assembly Residents in Dubuque need to realize that living in Dubuque is better thing for me financially. When I was living in Chicago, I was living in poverty trying to maintain myself. It is the reason why crime is so high in state of Illinois because lack of jobs and economic opportunity. I had signed up for a community engagement to volunteer to feed the homeless in Chicago on May 7 and 14, but I changed my mind because I wanted to get out of Illinois. I do not miss being in Illinois because of the financial situation and slow economy. Illinois Governor Bruce Rauner has suspended funding for social services and will not work with the Democratic controlled Illinois General Assembly. I sent two state budget proposal to Illinois General Assembly last summer to pass a state budget without raising tax on Illinois residents. The state budget proposals were \$32.9 billion and \$40.1 billion. It was rejected by nine Democrats mostly in the Illinois black caucus. As Senior Pastor, I donated \$1000 of my own money to help the homelessness in Chicago. Baptist Church of Douglass Park has donated nearly \$7000 of noncash donations to the homelessness in Chicago while I am pastor of the congregation. It was my idea to provide the Homelessness Financial Relief

Program to provide financial relief to the homelessness in Illinois because programs help Illinois residents pay their utility bills and household expenses to end homelessness. Baptist Church of Douglass Park and America Homelessness Coalition has spent \$2,000-\$3000 so far in Chicago based on receipts to help the homelessness. I like to expand Homelessness Financial Relief Program in Iowa, Indiana, Pennsylvania, New York, Mississippi, Georgia, California and South Carolina. Some Chicago residents that are homeless is addicted to heroin because the high crime rate since 1990s.

BACKGROUND CHECKS FOR PRIVATE SECTOR EMPLOYMENT OPPORTUNITIES

This country need to end background checks in this country based on sex abuse, felonies, criminal background, arrest records, sexual harassment and so on. Employers in this country need to give Americans in this country a second chance in life to succeed in the labor force. Homeless people at Pacific Garden Mission and Olive Branch Mission deserve a second chance to get their lives back on track. Ex-offenders and juveniles should not be held back from employment opportunities in the private sector. For example, UPS and FedEx do not hire people with a felony on their criminal record. Some employers do background checks and do not hire people with sex abuse and harassments on their criminal records, but not all employers. Large

businesses and retailers need to end credit background checks because people with bade credit deserve the right to good paying employment with permanent job security. A Black/African-American student in 2009 from Kennedy King College said that how do employers expect people to improve their credit score if they will not get hired for a job. Credit bureaus should be allowed to provide more flexibility for Americans. Some Americans that email Pastor Hobson do not have the extra money to pay on their personal debt and credit collection agencies call them over and over again. Community Employment Program do not provide background checks based on criminal and arrest records. Americans looking for jobs that will give them a second chance to get their live back on track.

HOMELESSNESS PREVENTION ROUNDTABLE IN CHICAGO

Community meeting took place in Douglass Park on May 7, 2016 at 2:00-3:30 pm. People in the meeting talked about how to reduce homelessness in Illinois low-income communities. People in the meeting talked about homeless people on long waitlists in Illinois for affordable housing. Pastor Hobson and other people in the meeting provided eightnew recommendations. It needs to be more affordable housing in Illinois and Chicago by passing the Homelessness Prevention Bill on Capitol Hill that is sitting in Congressional Committees. Homelessness Prevention Bill will provide \$50 billion for affordable housing in the United States of America. Funding for social services need to be unsuspended in Illinois to provide jobs and economic opportunity for homelessness and needy. Employers need to take a risks and hire ex-offenders for jobs in the private sector. Pastor Hobson and people in the meeting talked about ending depression and mass incarceration in Illinois. Reverend Meeks has lost ten percent of his members after he helped elect Bruce Rauner as Governor of Illinois in 2014. Pastor Hobson and people in the meeting talked about good paying jobs are needed in Illinois by reducing the tax burden and government regulations on small businesses. Pastor Hobson mentioned during that he mentioned to Illinois State senator at Illinois State Capitol about providing an environment study to make it easier to start

a business in Illinois. Money was donated to help the children in poverty on May 7, 2016. Funding and grants was donated to the help the homelessness in Chicago on May 7, 2016. Donations will be recorded on the financial reports and monthly treasurer reports. Pastor Hobson says that more outreach needs to be done to help children in poverty because it was funding donations donated children poverty campaigns twice so far. It is more donations and financial assistance planning to come in Chicago to end homeless homelessness. Baptist Church of Douglass Park started out with no money in 2014 and able to give back to the homelessness and needy in Illinois. It was over \$9,141 in financial assistance and donations provided to the homelessness in Chicago among black/African-Americans and Latinos since 2014. It was over \$8,306 noncash donated to the homelessness and needy in Chicago since 2014. Pastor Hobson knows what he is talking about on taxes and economy. When you raise taxes in the economy, you are providing poverty for Americans and slow economy. Pastor Hobson actually heard talked and listened to Black/African-Americans in Chicago that they pay too many taxes up to summer 2015. Pastor Hobson actually heard and talked to Black/African-Americans in Chicago that are feeling financially squeezed in their households up to summer 2015. Pastor Hobson had actually heard Black/African-Americans say that Democrats in Illinois General Assembly make them angry with the increasing taxes and tax burden. Four people were awarded financial assistance from Homelessness Financial Relief Program in Chicago on May 7, 2016. It means one hundred five (105) people signed up and awarded financial assistance since 2014. Real change is coming to Illinois. Employment in Community Employment Program was slow in May 2016 and no new jobs was provided in Illinois. Food processed and not consumed in the United States of America need to be provided to the needy and homelessness in urban and rural areas. It will reduce food waste in this country. Unpopular food items not consumed need to be donated to food pantries and homeless shelters to feed the needy and homelessness in this country. Budget Committee plan to spend \$20 for Chicago homelessness outreach in June 2016. Total enrollment plan to increase for Homelessness Financial Relief Program in June 2016 to one hundred five (105) Chicago residents. Pastor Hobson has a family and relatives on 114th and Church Street in Chicago that do not care about Pastor Hobson since he was a child. Family lives at 11440 South Church Street and 112th Church Street. Pastor Hobson biological father name Michael Cooper that did nothing for him up to age 21. Eilean Elzy-Weaver that lives at 11440 South Church Street along with her late husband and adopted daughter Courtney Elzy think they know everything. They are wrong and always wrong. Bobbie Redmond that lives in the same household says Pastor Hobson were autistic while he was young. She is wrong and always wrong too. Pastor Hobson did not have autism as a child. Family live at 11440 South Church Street has not done nothing for Pastor Hobson while he was young and do not support him for nothing. Pastor Hobson was raised by his mother and step-father Leon and Sheila Williams because his biological father Michael Cooper did not want to take responsibility. Pastor Hobson and staff want to let people to know ignore Eilean Elzy-Weaver, Joyce Cooper, Bobbie Redmond, Michael Cooper, Shirley and JT Cooper, Leon Weaver, Courtney Elzy and so on because they are wrong and dishonest. Budget Committee members used 56% of the budget for salaries and wages. It was two percent (2%) of the budget appropriate homelessness social service programs. Budget Committee members used one percent (1%) of the budget for church operations. Information came from the Budget Committee member in Chicago-Douglass Park on May 4, 2016. Pastor Hobson provided five budgets to Capitol Hill to protect social security long-term. One federal budget to Capitol Hill in 2011 was a plan to lower the federal debt by \$5.7 trillion and provide \$1 trillion in Social Security Trust Fund. Another federal budget to Capitol Hill was a plan to eliminate the IRS and provides a Federal Gradual Income Tax. Federal Gradual Income Tax will provide a 40% federal payroll and federal tax for millionaires and billionaires, 30% payroll and income tax for upper middle-income households, 20% federal payroll and income tax for lower middle-income households, and 10% federal payroll and income tax for low-income households. Americans earning less than \$50,000/year would be allowed to pay ten percent payroll and income tax under the federal budget proposals long-term. Americans earning \$50,000-\$150,000/year would be allowed to pay 20% federal income and payroll tax under the federal budget proposals long-term. Americans earning more than \$150,000-\$250,000/year would be allowed to pay 30% federal income and payroll tax under the federal budget proposals long-term. Americans earning more than \$250,000/year would be allowed to pay 40% federal income and payroll tax long-term. A millionaire that earn \$1 million for gross pay will pay \$400,000 for federal payroll tax and still earn \$600,000 net pay. A billionaire that earn \$1 billion for gross pay will pay \$400 million for federal payroll tax long-term and still earn \$600 million net pay. Lower taxes increases wages in the private as well as strengthen pocketbooks for American households among the 99%.
